- "Number of Students Who Began the Program" means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- "Students Available for Graduation" is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.

# STUDENTS RIGHT TO CANCEL

The student has the right to a full refund of all charges except for the amount of \$100 for registration fee, if notice of cancellation is made through attendance of the first-class session, or the seventh day after enrollment, whichever is later. The amount retained for registration fee shall be \$100. ## **Refund Information**

In all cases of Students who withdraw, or who are suspended or expelled, the following refund policy shall apply:

The refund of tuition and others fees (excluding material fee) for students who have completed 60% or less of the period of attendance shall receive a pro rata refund. Returned kits may be subject to a reconditioning fee of up to 50% based on their returned condition. If the Student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. Credits or Refunds shall be paid within 45 days of cancellation or withdrawal.

If the Student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student has received federal student financial aid funds the student is entitled to a refund of moneys not paid from federal student financial aid funds.

If a student defaults on a federal loan, both the following may occur:

1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.

2) The student may not be eligible for any other federal student financial aid at another institution or other government financial assistance until the loan is repaid.
