In all cases of Students who withdraw, or who are suspended or expelled, the following refund policy shall apply:

The refund of tuition and others fees (excluding material fee) for students who have completed 60% or less of the period of attendance shall receive a pro rata refund. Returned kits may be subject to a reconditioning fee of up to 50% based on their returned condition.
